Minutes of the Parish Council meeting held on Thursday 10th August 2017 in Stonesfield Village Hall.

- 182. **Minutes** of the meeting held on 13th July 2017 were approved and signed with the correction of misspelling of Cllr Geraldine Lawrence's name.

183. **Matters of report arising from previous minutes** Waste bin required for playing field and need to establish where it should be

positioned and ascertain if WODC can handle emptying it. Also possible requirement for more waste bins in Stonesfield. **Clerk to investigate**

184. District Councillor Report

Cllr Richard Bishop reported that the Local Plan consultation was now over. There had been some excellent speakers. The Inspector had taken on board all that was said. Cllr Bishop was hoping for a review on all areas in the AONB. A site meeting would be undertaken for the Cala property development which was most unusual but could have been due to Sustainable Stonesfield's endeavours. Residents could attend the site meeting however questions can only be asked at Committee Meetings and a booked speaker can only have three minutes time at the meeting. If Sustainable Stonesfield choose to put forward a speaker there can only be one person representing them. An appointment to speak must be made in advance of the Committee Meeting.

185. Playing Field Report

- 185.1 The MUGA has been completed with the exception of a small area yet to be paved. Members are pleased with the new surface to the tennis courts. The next stage is to apply for floodlighting which requires careful planning.
- 185.2 Mast a new location has been identified for the mobile phone mast which is the same size as the original one. It is planned to be positioned at the hedge behind the tennis courts and is waiting for the Playing Field Committee's approval. SPC to send letter of support when planning application submitted.

186. SCT report

There was nothing to report. The Charities Commission had given approval for the sale of land to Oxford Council Trust.

188. Village Hall

It was agreed to pay the Village Hall their grant of £2000 for 2016/17 plus the outstanding monies from their grants in £400 £2015/16 and £900 2014/15 total £3300. Proposed by Frank Huddleston, seconded by David Baldwin.

RESOLVED grant to be paid to Village Hall £3,300.

189. Glebe Land

- 189.1 The purchase of land for the Scouts has gone through and it is hoped that the lease will be in place by October.
- 189.2 The lease allows for use of land for the following:
 - a. educational purposes

- b. can be use by scouts from other areas
- c. community use

The scouts are paying the legal fees. It was proposed that the land should be leased to the 1st Stonesfield Scouts at a peppercorn rent. The lease should be returned to SPC in the event that 1st Stonesfield Scouts should cease to exist. Proposed by David Brown, seconded by Frank Huddleston
