### <u>Grants</u>

The clerk is continuing to look in to updating the grant policy and hopes to bring to a meeting soon for approval in time for the next financial year. It seems that the maximum limit for any grant should not exceed £2,000 as SPC are a small local council.

Most parishes of SPC size grant £200-£500 maximum.

### Pension

The clerk is working with the pensions team to enrol into the pension scheme. This has progressed and we are now registered with LGPS. The clerk is meeting the pensions team for OCC on 11<sup>th</sup> September at their offices to finalise.

The clerk has been in contact with WODC and is meeting with them next week as there are some very strict rules and timings which the current SPC plans don't seem to meet. The clerk will find out and report back.

A member of the parish has asked for the litter bin on the Church Street kerb to be moved as its very close to their house window. The clerk asks Councillors to consider if there is any issue with this and where to move it to.
