# 294. Declarations of pecuniary interest. None

**295. The Minutes of the meeting** held on October 2020 were approved with the following amendments:

It was proposed to make an amendment to section 291 in November 2020 minutes to add the following "The letters did however ask that as our representatives we looked to use all moral, legal and financial tools available to support saving the White Horse as an asset for the whole community.

Stockey Woods – note D Baldwin abstained rather than did not agree with decision. Item 287 Remove words: grant given on this basis from item.

# 296. Matters Arising from the minutes October 2020

White Horse pub – The Council has not surveyed the village for opinion on the pub to date and Cllr Baldwin asked that it is made clear that the parish has not yet been surveyed by council.

# 297. Public Participation

Ollie Stobo (member of public, local farmer) – question sent in advance and circulated to councillors: Regarding dog walking on his private ground Mr Stobo asked how the parish council can help stop the continued trespassing on two of his fields. One of which is a Mid-Tier Stewardship scheme for Natural England on Combe Road and the other is an arable field on the top of Stocky Wood near the Common. Dog walkers are destroying the habitat that he is trying to manage for environmental stewardship. People are climbing the wall to walk on the land but they are trespassing. It was decided that the clerk with work with Ollie to add a note to the slate and the parish website.

298. White Horse Community Pub Group

Several members of the pub group attended the meeting as requested by the clerk in order for them to provide a parish update. They updated parish councillors advising them that just under £200k share sales have been made for the White Horse Pub. This is a fantastic response from the village, 167 members. There is still a long way to go.

It was made known to the council that the excerpt published in the slate from last month's minutes had inferred that the whole council thought the business plan was unsound. We clarify that the concern about the draft business plan was raised by one councillor and is not necessarily the view of the whole parish council. The excerpt in the slate was a snapshot of the minutes. Full minutes with all the detail will be published online.

The council re-iterated their support for the Pub Group and understand many of the community benefits a successful project will bring the village and look forward to working with a successful group

There was emotive discussion amongst all members of the meeting regarding this topic.

Cllr P McArdell and Cllr D Brown have been invited to a meeting with Robert Courts, the Plunkett Foundation and the White Horse Community Pub. The clerk will also attend. There is no agenda and this is an open discussion.

#### 299. Reports from Councillors, District Councillors

Reports from Cllr Hudspeth and Cllr Bishop were circulated to councillors ahead of the meeting. There were no additional comments.

#### 300. Questions arising from the clerk's report

Finance – Cllr Gould noted the figures are confirming that the budget is not good and it needs discussion. The clerk reminded councillors that they have a legal obligation to keep to budget.

Clerks appraisal – It was agreed that the appraisal policy will be looked at so that all councillors can input well ahead of the appraisal if they wish.

Legal issues with playing field – the clerk received an update just before the meeting regarding legal issues. The clerk advised that we have no formal clarification but that the solicitor is not seeing issues on the playing field transfer and is liaising with the other party solicitor. We hope to finalise before the end of December. The legal process regarding North Farm is awaiting a response from the other party solicitor. We also await the fence to be put up before signing.

1) The development hereby permitted shall begin not later than 3 years from the date of this decision.

2) The development hereby permitted shall be carried out in accordance with the following approved plans: Location Plan Drawing Number 196318/20:1; Block Plan Drawing Number 196318/20:2; As existing floor plan and elevations Drawing Number 196318/20:3 and As proposed floor plan and elevations Drawing Number 196318/20:4.

Cllr Baldwin asked if the clerk would renew interest in the white horse pub as a community asset when it is due. Councillors **resolved** unanimously to renew the registration of the pub as a community asset when it is due in January 2021.

Councillors **RESOLVED** to make a payment of £50 for a poppy wreath for the Royal British Legion. The clerk will raise a cheque.

Grant requests. A grant request came in from the Playing Fields Committee for funds in the next financial year. Councillors deferred considering this until we have considered the next financial year budget as we do not know the grant budget at this time. The clerk will add it to the December agenda.

The clerk reminded councillors that the parish council needs to spend within budget and that when budget conversations are had grants need to be considered and budgeted carefully. Councilors have a legal responsibility to work within budgets set.

Cllr Baldwin explained that the playing fields committee sent their form in early so that it could be budgeted.

Councillors agreed to set a date for a budget meeting: Wednesday 25th November at 7pm. The clerk will circulate a zoom link. Councillors must send any preparation for budget input to Cllr McArdell and the clerk by 20<sup>th</sup> November. A draft budget option will be sent to councillors ahead of the meeting by Cllr McArdell.

Cllr Baldwin noted that Stonesfield Mutual Aid are trying to negotiate to get the lunch club going again (perhaps through delivery) and looking to establish some sort of food bank. They are looking at a reverse advert calendar / food bank options. It is not known if further financial support will be requested at the moment.

#### 303. Stockey Woods

Cllr Brown explained that Freeths are still proceeding with the enquiry at the moment, nothing much has changed but we feel there is a strong case and we are quietly confident of a good outcome. Updates will follow.

## 304. AOB

- Cllr G Lawrence asked the clerk about access to the village hall. The clerk advised that if we need access Jacquie can provide it but we won't have a code for access during Covid.

- Cllr G Lawrence will give the defibrillator code to Ben at the social club. The clerk will note this in the slate.

- Cllr D Brown received a report from a member of the parish regarding vandalism to a van in Longore. The clerk will report it to the police.

- The Clerk suggested writing a report for the slate detailing all of the positive things the council has done for the village over the year. Councillors are to send items to include in this by the end of the week to the clerk.
