(22/449.01) The District and County Council are now separated.

(22/449.02) Exploring the options of a shuttle bus from Stonesfield to Woodstock for youth services. (22/449.03) Consultation document regarding bus services on Lets Talk Oxfordshire – important to try and retain bus services. Rural areas can be cut first so please take a look and comment.

(22/449.04) The health services in Woodstock are being discussed by the council at County level. *Cllr Matthew Parkinson & Cllr Nathalie Chapple*

(22/449.05) People are encourage to put holes in hedges etc. to encourage hedgehogs (Hedgehog Highways).

(22/449.06) 1712 businesses to date have received Covid support funding from District level.
