23/571 Public Participation

Scouts representatives attended the meeting. Scouts have the planning permission and fundraising to date has been relatively successful. Further monies are needed but work can commence. Scouts will be letter dropping those nearest to the scout hut to provide further information and an update will go in the February slate. The builder for the scout hut is a local person.

It is noted that the steps at the scout hut need to be made safer. The scouts are looking in to this. Right of way needs to be re-routed as it is unsafe. The clerk will link the scouts to the officer at WODC.

It was noted that Stonesfield Parish Council supports Bladon's response to the Botley West solar park, the Bladon response was very detailed.

Cllr A Graham

There is a £2 bus scheme in place for reduced travel. There may be a scheme for a reduced bus scheme for young people on the buses coming in.

Cabinet is touring, the clerk will liaise with Cllr Graham to see if we can host a cabinet meeting in the village.

Cllr Matthew Parkinson

The cabinet has decided not to have pavement licences, which should encourage people back on to the High Street.

Cllr Wendy Gould

Residents complaining about blocked drains and potholes – the clerk will contact Cllr Andy Graham. Neighbourhood plan meeting held recently focussed mainly on the survey. Councillors have been sent the survey to complete.

Survey printing – coloured £995. Coloured will be need for the maps. The council has encouraged the NP plan team to apply for grants and the clerk can add any finance information from the parish council. Suggestion to also look at social media options.

Community Trust are meeting with NP w/c 16th January.

Graffiti at bus shelter – the clerk can arrange cleaning but Cllr Brown will also ask Ian Hedges if he can paint it in anti graffiti paint in the first instance.

Overgrown hedge on Pond Hill is causing a problem. The clerk will ask OCC to cut it as it is blocking the highway view. Councillors are asked to log this on fix my street too.

White Horse pub is on the market (as a pub) for £550k.

Cllr David Brown

Information has been shared regarding the defibrillator – the clerk confirmed it is registered with SCAS (Ambulance service) – the clerk will see if we can encourage people to sign up as first responders in the village.

Playing Fields Association wish to buy a hedge cutter – suggestion is that they look at grants and potentially put a grant form in the future. It is possible the parish council could use them for hedge cutting.

Cllr Mick Heduan

There have been 4 incidents of vandalism on the SID at the war memorial. The SID will be moved to another location. Outstanding order at Morelock has been chased up by Cllr Heduan.

Cllr Simon Powell – Susan Rudlin has advised that the reverse advent calendar was a success.

It should be noted that the £1,500 to the pub group is a refund of monies paid to the Parish Council by the pub group. The MJD Hughes valuers cheque was cancelled and therefore the pub group did not need to reimburse the parish council.
