(23/585.03) There was a grant request for the consideration at the meeting for the Scouts. Grant awarded for the sum of £1,000. Councillors have **RESOLVED** to pay this grant in full. Proposed Cllr O'Brien, Seconded Cllr Powell.

(23/585.04) The council considered and rejected a grant submitted by the Stonesfield food group. Although council thought the case for the grant was good the bank details were for a personal bank account which is not permitted. The clerk will advise the group to resubmit when they have a bank account for the organization.

4 Limbeck Way, Stonesfield (Cllr M Heduan declared conflict of interest) – No Objection or comment 11 Cockshoot Close (notification of appeal) – not a consultee as this has gone to a higher level so no comment.

The Cottage at the Cross – Council supports the work but OBJECTS on the grounds that Stonesfield slate roof material is being changed to replica. This goes against the heritage of the area. We expect this work and all remedial work on properties in Stonesfield to be repaired using Stonesfield slates.
