Stonesfield Parish Council Report from District Councillor Genny Early 11 June 2024

After my first month in role, I thought it might be useful to outline what the actual job has involved so far.

The work of the council and its paid officers covers the areas of planning, waste collections, maintenance, business support, grant-making, affordable housing, homelessness & supporting parish councils.

The council is currently governed by an alliance of The Liberal Democrat, Labour and Green groups, which was agreed first in 2022, and agreed to continue, following the May 2nd 2024 elections.

The council is now made up of 21 Liberal Democrats, 13 Conservative, 11 Labour and four Green Party councillors.

My role as a district councillor is to work within the systems as they now are, trying to make sure that the existing policies are followed while also changing the conversation, working out what needs changing, and feeding in ideas for policies when they are reviewed.

Together with Cllr Tim Sumner, our role is also to try to connect the 4 parish councils and the residents in the Stonesfield & Tackley ward with the help that residents need on all WODC matters, and others. It also involves supporting community groups, and connecting them with sources of help.

Home Upgrade Grant (HUG2)

Home Upgrade Grant (HUG2) funding was awarded in 2023 to Oxfordshire County Council to retrofit the homes of low-income residents living in energy inefficient homes (up to £38,000 per property). Responsibilities

I sit on the Overview and Scrutiny Committee.

One proposal going to the Executive Committee this month is to upgrade the public open space CCTV cameras covering the areas of Carterton and Witney to high definition digital, together with the installation of five new cameras in Chipping Norton. It further recommends the Council joins the Thames Valley Police CCTV partnership, with an associated transfer of CCTV assets and operational responsibility to TVP under a 'single owner' model; and moving monitoring arrangements to a shared Oxfordshire hub.

I also act as substitute on the Uplands Planning Committee, which I will be attending this month.

Polecats are in the region! I found a roadkill pole cat between Witney and Curbridge. Polecats were trapped pretty much to extinction at the end of the 19th century. So it is great news that they are recolonising lowland Southern and central Britain.

The local rare plant: now is the time for Meadow clary to flower! It is still holding its own in lots of sites located around Stonesfield, including at Combe, the Saltway and at Stonesfield Common. Let me know if you would like to be involved in monitoring and safeguarding these rare plants, which are a lovely reminder of what the Romans ever did for us.
